

## All tiers of membership must:

The categories and associated rules of each category are:-

#### 1) General Member

Rules

- a) An individual who is either a resident (past or present) or a current rate payer of the "North of the River" community.
- b) Must be over 18 years of age.
- c) Will have full voting rights.
- d) Cost will be \$25.00 per annum.

### 2) Associate Member

Rules

- a) Will not have voting rights.

- c) There are no age restrictions.
- d) Allowed to attend general meetings.
- e) Membership fee \$20.00 per annum.
